Daycare Enrollment Guide (for the year of Reiwa 7; 2025) □

This guide describes the matters and procedures required to apply for childcare facilities of Tochigi City. If you are going to enroll your child, please be sure to read this information. Please complete all the forms and submit them by the deadline.

1. Certification of the Necessity of Childcare

Certification of the necessity of childcare (Benefit Certification) must be obtained before your child starts attending kindergarten/daycare. There are two types of Certifications of Necessity of Childcare (Benefit Certification): 1. An Education and Benefit Certification and 2. A Facilities Use Certification.

5. Application Procedures for Childcare Facilities

Application

- ·Apply to Tochigi City Hall to use a childcare facility. If your first choice of childcare facility is a certified childcare facility, please submit the application to the facility directly.
- ・保育施設の利用許可を市役所に申請してください。認定こども園を第一希望の場合は、認定こども園に申請書を提出してください。

Facility Interviews

- · We will conduct a face to face interview after application. Attend the interview at the designated venue (Local community center, your first choice of the childcare facility etc.) with your child.
- ・お申し込み後、対面での面接を実施します。指定の会場(地域の公民館、第一希望の保育施設等)にお子様と一緒にご来場ください。

Screening

- ·Based on municipal regulations, admission will be decided on a priority basis, taking into consideration the parent(s)'/guardian(s)' circumstances and childcare needs.
- ・市町村の条例に基づき、保護者の状況に応じて保育の必要性に応じて優先的に入所が決定されます。

Screening Results

- ·We will send a notification of decision by post.
- ・決定の通知は郵送にて行います。

Notification of provisional enrollment decision

- ·For the 1st through 3rd application period, the city will send an initial decision letter on the cheduled date.
 - · If you apply in mid-year, the city will contact you before you start using the facility.
 - ・一斉申し込みの場合は、予定された日に内定通知を市から発送します。
 - ・年度途中の申込は、利用開始月の前月上旬に利用調整のため市から電話があります。

If you do not receive a provisional enrollment decision

- · For the 1st through 3rd applications, the city will send a notice of pending enrollment on the scheduled notification date.
- ·For applications made in mid-year, the city will send out a notice of pending enrollment around the 15th of the month in which you have planned to start using the facility.
- ·We will continue to adjust admissions during the certification period within the fiscal year.

Entrance information session and Health check

- ·We will notify you of the date and location of the entrance information session along with the notification of the screening results. The event will be held at a childcare facility where admission has been decided. (If the childcare facility you have been offered an offer at is a childcare center(Nursery section) or a Small childcare facility, you will be contacted by each facility.)

Enrollment

- ·The childcare facility will inform you of the childcare fees and meal fees after enrollmentl.

- The calculation of the basic childcare fee is based on the total amount of resident tax of both parents/guardians.
- ·Childcare fees are decided on a monthly basis.
- · Even if your child misses attending daycare due to personal circumstances, you are still to pay fees.
- ・基本保育料の計算は、保護者の住民税所得割額に基づきます。

- · Fees for class groups of ages 3-5 are free.
- ·If there are two or more children under the age of 18 (\times) living in the same household as their guardian(s), children between the ages of 0 and 2 who are certified for childcare and attend childcare are exempt from childcare fees from September Reiwa 6 (2024).
- ・3~5歳児クラスは無料です。
- ・保護者と同一の世帯に 18 歳未満の児童(※)が 2 人以上いる場合、0 歳から 2 歳児の保育認定を受けて保育園等を利用する児童は、令和 6 年 9 月から 保育料が無償となります。
- ·If both parents are municipal tax-exempted, we will consider the highest municipal tax payer (lineal blood relatives such as grandparent(s)) in your household.
 - · Note that residence tax amount of either married parents living apart or unmarried parents living together will also be considered.
 - ・両親ともに市税非課税の場合は、直系血族(祖父母など)である同居者の最も高い市税所得割額を考慮します。
 - ・別居中の夫婦、または同居中の未婚の夫婦の住民税額も考慮します。

3) Daycare Meal Fees

Based on the policy to make pre-school education and childcare services free, childcare services for children from 3-year-old to 5-years-old classes are free of charge. You will, however, be charged for school meal fees. School meal fees are collected by each facility. However, for public daycare facilities, the city collects the fees. For children in the 0-2 year old class, the cost of school meals is included in the childcare fee,

幼児教育・保育の無償化により、3歳児から5歳児までの保育料は無料となります。ただし、給食費は実費となります。

給食費は、各施設が徴収します。ただし、公立園については市が徴収します。

 $0\sim2$ 歳児クラスの児童は、保育料に給食費が含まれますので、原則給食費の支払は不要です。

7. Others

If you live outside of Tochigi City but wish to enroll your child in a childcare facility within the city,

Please apply to your municipality. Please contact them in advance because conditions and requirements may differ.

Application documents will be sent to Tochigi city through your municipality and Tochigi city will screen applicants.

Please apply at least one week before the application deadline to ensure that the documents will arrive before the deadline.

*Those who live outside the city cannot apply in the first application period.
